The LEP plans to use the funding to support reading interventionists that will provide targeted, evidence based intervention services to students on READ plans. We will also use fiunding to support in the cost of approved reading intervention programs at our schools. At Connections Summit Academy, we will utilize funds for reading interventionists who are trained in the science of reading to provide direct intervention with students who are on a READ Plan and support their access to MyPath as a supplemental reading program. At Colorado Preparatory Academy Elementary, we will also use funding to support reading interventionists who will also work directly with students on READ Plans to provide supplemental Reading instruction in addition to the Core. Finally at Orton Academy, we will use READ Act funds to support both Take Flight from Texas Scottish Rite Hospital for Children with students in grades 2 & 3 who are on a read plan, as well as Lexia as a supplemental reading resources.
