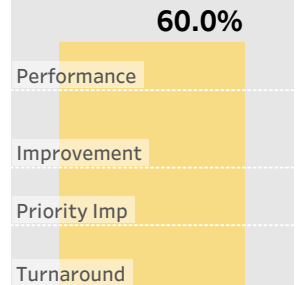


**Plan Type Official Rating Based On: 1-Year SPF Report**
