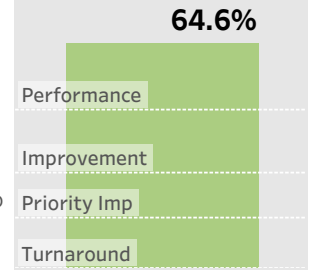


## Plan Type Official Rating based on 1-Year SPF Report
