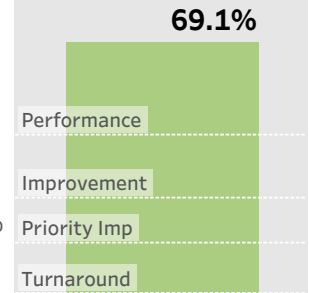

AYGs designate Anticipated Years of Graduation, which are defined as four years after the year that students initially enroll in 9th grade.
